K. <u>Report of the Superintendent</u>

First off, you may not be aware, but January is School Board Appreciation Month so I wanted to take that as an opportunity to just, from my perspective, express thanks and appreciation to the Board. It's a volunteer position, it's a lot of hours and it's a really important civil service. I appreciate all of the time you put in and working with me and the Administration and I'd like to offer up a round of applause for our Board.

One of the things we started before the new year really with outreach from our Township Committee and Deputy Mayor Impreveduto, was really improving and building upon collaboration between the Township Committee and the Board. So, we've begun what we were calling liaison's meetings, and those will continue into the new year in discussing and working on projects that are of mutual importance to our constituents. One really basic thing that came out of one of those meetings was the idea of just sharing information from the school district to be included in the Township's monthly newsletter. So we will submit a school district 'column', if you will, or if they are printing electronic newsletters, it's a really important opportunity to share with a wider community what is going on in our schools because, while the community no longer votes on the school budget, their taxes continue to fund the school budget. So it's really important that we continue to try and bring those folks into the fold. Also, the Township Committee's been gracious to reach out and ask if there's any updates to share with the Township Committee. So I think I can speak for our Board that we're excited to continue that collaboration and connection with the Township Committee and we appreciate the Township Committee for their willingness to engage with us.

On Monday the 23rd, as you know, the District was closed to students but all of our staff were in for a full professional development day. The day was held at the High School Complex and contained a

whole host of different types of workshops from Literacy Instruction to Classroom Management to the first major portion of our training with the Lifelines program, which is part of the Monmouth Mental Health Association, to ensure that we have robust systems of not only suicide prevention as well as suicide intervention and postvention.

Just to piggyback on what President Reddy said was that the National Honor Society inducted 96 students. I've been in a number of school districts and I've seen a number of National Honor Society ceremonies and this one was, no joke, the best I've seen. It was really well done and had a lot of nice features to it that I hadn't seen done before. Kudos to, obviously, the students, their families, the teacher sponsors who were nominated as well and all those who put effort into organizing it.

Another fun experience was checking out the Satz Winter Musical last Friday. I love watching the kids perform and they did a great job. They did High School Musical Junior and I never cease to be amazed by how talented and committed our kids are to that.

 - Mr. Wall referenced getting the agenda out as soon as possible (but at least 48 hours prior to the Board Meeting) and that when the agenda is posted that it is not marked as "draft". Dr. Cascone responded accordingly.
 - Mrs. Briamonte referenced the Jersey Shore Chinese School's Lunar New Year celebration and encouraged everyone to attend.
 - Mr. Reddy thanked Administration for having coffee/water for the public meeting. He referenced the Varsity Hockey Team (co-op with the Marlboro Team). They recently raised \$6,600 for the American Cancer Society and the Emmanuel Cancer Foundation for pediatric cancer patients. Holmdel High School Alumni, graduate from last year and cancer survivor, Tony Salerno, accepted the donation on behalf of the Emmanuel Foundation at its first ever 'Hockey Bites Cancer' Game. Thank you for your efforts, it was an amazing night and Holmdel won 9-6.
 - Mr. Reddy also mentioned that our new SRO Officer, Michael Nolan, is a Holmdel High School Graduate, Class of 2012 and thanked Officer Maguire for his years of service.
- R. Questions or Comments from the Public
 - Mr. O'Conner, HYAA Basketball Coach/Parent, referenced a former speaker (Mykee Fowlin) at William R. Satz Middle School. Parents were notified of the speaker and approximately 100 students

were pulled out just prior to the presentation occurring. He then referenced the recent speaker (David Damico) and expressed concerns with what was communicated and with Satz School Administration and stated that he has lost his trust with Administration. He asked the Superintendent and the Board about the vetting process and asked the Board to be more transparent. Mr. O'Connor stated that we need to get ahead of this stuff and be more proactive, instead of reactive.

Mr. Reddy thanked Mr. O'Connor for his statements and Dr. Cascone responded, sharing that the presentation led to a lot of really tough and important conversations. Dr. Cascone shared the district is extremely careful in our hiring process to ensure staff are the right fit for the district. Historically, the vetting process for some of these speakers has not been nearly as tight as it should have been. Dr. Cascone shared that he was present for a majority of the assembly and felt there was a number of constructive and appropriate messages delivered, however, the speaker's treatment of certain topics were not valid and, in some cases, they just involved incorrect information. Dr. Cascone shared that, going forward, all outside speakers will be run through Curriculum & Instruction with certain checks and balances in place. It is important for us to review the presentation and any materials or information they will be sharing, in advance, so we know exactly what they will be sharing and can provide this information to parents, in advance. There is an upcoming assembly on the 27th and Dr. Cascone shared that he did the vetting for this particular speaker. On the downside, this situation has led to lost confidence in Administration, however, on the upside, this situation led to a host of improvements that will be utilized going forward. Dr. Cascone stated he understands trust and confidence do not get rebuilt overnight. He shared that he appreciated Mr. O'Connor's comments and stated the message has been received, loudly and clearly.

Mr. O'Conner had follow up comments regarding the possible establishment of a parent group to search/vet future speakers.

- Mrs. Kolovos, Parent, referenced the OPRA request regarding Executive Session Meeting minutes from January 2022 December 2022. Mr. Green responded that the Executive Session Meeting Minutes were provided with redactions and stated that he would speak to her after the meeting.
- Mr. Purcell, Parent, referenced the assembly that occurred last week regarding CRT that had a negative impact on students. He stated Administration should practice what they teach Resign and give your position to persons of color. Parents need to be aware of what your children are being taught in school. Mr. Reddy thanked Mr. Purcell for his comments and stated that this is an opportunity to do better, as a Board, as a District and as a town.
- Mr. Lupe, Parent, referenced the concerns expressed tonight regarding presentations and suggested including potential speaker names as an agenda item, in advance, so it's public and parents will have details and can do their own research. He also congratulated the new Board members and thanked Dr. Kukoda for his efforts at the High School with the memorial that impacted his family. He referenced the budget discussion and ways to improve. He suggested treating every dollar 'like it's coming out of your own pocket'.

S. <u>Executive Session (if required)</u>

Board President Reddy stated there was a need to go into Executive Session to discuss items regarding attorney/client privilege and labor relations matters. He stated no further action will be taken and they will adjourn from Executive Session and will not be returning to public session.

2610 EDUCATIONAL PROGRAM EVALUATION

The Board of Education directs the Superintendent to develop and implement a systematic plan for the continuous evaluation of the educational program against the educational goals established by this Board. To this end, tThe Superintendent shall employ such tests and methods that will ensure decision making is data driven and a variety of sources of data are used to analyze and monitor student achievement and progress, as well as evaluate school programs as may be indicated by sound professional judgment. Wherever possible, the assessment program shall follow evaluation procedures set forth in the course guides.

The Superintendent shall maintain a calendar of assessment activities and shall make periodic evaluation reports to the Board during the school year. Findings of the assessment program, that evaluate the progress of students and the effectiveness of staff members. The Superintendent shall use multiple (more than two) sources of data to monitor student achievement and the progress of students. The Superintendent shall also use multiple (more than two) sources of data to evaluate the effectiveness of programs, initiatives, and strategies.

The Board will annually make available to the public the collective progress of students toward the goals of the district. The Board will annually, prior to the end of the school year and in conjunction with appropriate members of the administrative staff, conduct a review of the educational progress of the district, assess district and student needs, and establish long range and short range objectives for the educational program. The Board's annual report will be submitted to the Commissioner of Education as required.

The Superintendent shall annually recommend improvements in the educational program based on the Board's evaluation of the district's program. The Board reserves the right to employ experts from outside the school district to serve in the evaluation process.
