K. Report of the Superintendent

- Enrollment Data – Total Student Enrollment: 2,941

Thank you Mr. President. I just want to start off with an update on student enrollment. As of today, we have 2,941 students enrolled in the district. This is a 21 student increase since the time of the October 15th student enrollment report to the state.

This week, we passed a milestone, we had our hundredth day of school. It's hard to believe that we're more than halfway through the year and with the spring weather out there it feels like we are even further along. It was a good week in the schools and we also celebrated Random Acts of Kindness week so, in a number of our schools, teachers and school principals engaged in a number of activities including students filling out anonymous encouragement cards to share with their classmates and schoolmates. Obviously, an appropriate activity for this week as we celebrated Valentine's Day.

We also celebrated Valentine's Day by welcoming the County Executive Superintendent into our school district for the 3-year NJQSAC school district audit and evaluation. This 3-year process monitors the school district in key areas of personnel, finance, operations, governance, and most importantly instruction and programs. Now, while we will not have our ultimate score until the end of the school year, I can tell you that the feedback that we received from our visiting team was very positive. They were very impressed with our presentation and with the documentation shared and one other additional point is they do walkthroughs of our all school facilities to ensure that our facilities are up to date with all appropriate policies, statute and regulation.

I wanted to provide a couple updates on some items that Vice President Wall brought up under new business at last month's meeting. The first is pertaining to a trailer that is currently on our school grounds and is the property of one of our local recreation associations. We began communications with the leadership of that organization in the spring of last year to understand they were looking to donate an updated trailer and relocate that trailer to the Roggy Field site. As part of our conversations, I had an opportunity to tour that trailer and I certainly concurred that this is a trailer that should probably be updated and refreshed. We also did a site walkthrough to understand what might be a good location to locate that. Last we left off, we were looking to receive some additional schematics from the organization to understand what kind of site accommodations would need to be made and I had reached back out to the organization to renew that conversation and obviously we're here to assist and partner with that organization accordingly so that their athletes (our students) have a safe and comfortable place to gather on their game days and practices.

Another item I just wanted to update the community on was with respect to the field that is adjacent to Village School which is utilized primarily by the HYAA Lacrosse Program. In the spring of last year, when I came to the district, we had received feedback that the state of that field was in need of some improvement. In particular, the grass had been growing unevenly and represented, perhaps, a hazard for our athletes. So, at that time, our Grounds Department did what was known as slit-seeding to the field, really encouraging new growth of turf and that really did the trick. So, based upon feedback from the last meeting, I did have our Grounds Department do a recent inspection of that site and Mr. Stromsland provided some updates on what they're going to do between now and the opening of that season to ensure that the field is in proper condition. By the end of February, the grounds-keeping staff will continue their program by adding an organic fertilizer across the entire field. Realizing that the field areas around the Lacrosse goals get more wear than other parts of the field, they will also add more organic material with some over-seeding in those areas to encourage better and more even growth. So I just wanted to, out of due diligence, follow up on those two points brought forth at the last meeting.

I would also like to call attention to a really important endeavor in which we're undertaking now which is the strategic plan. I get really excited about the strategic plan because there is so much promise in this activity for our community to really through stakeholder feedback, develop goals and a blueprint moving forward for our school community for the next five years. So, the first step in that was a survey that went home to the families and one also went to the staff. So, if you haven't had an opportunity to fill that strategic plan survey out, please do. I'll continue to put out reminders through my weekly updates. We're looking for 90% participation in that survey, which is ambitious, when compared to our standard participation. I cannot overemphasize the importance and the value of the community's feedback for that survey.

Anugna stole my thunder a little bit on the February 27<sup>th</sup> cyber safety presentation but I think it absolutely merits some reiteration. We will have a gentleman by the name of Clayton Cranford. He is the author of Parenting in a Digital World, presenting to our parents that evening on how, as parents, you can keep your kids safe and make good decisions with regard to smart devices and social media. That presentation will also be made to all our sixth graders at Indian Hill, of course appropriately for the students, and to our Satz Middle School students. That presentation will be live streamed. So, if you're not able to attend in person, certainly, we hope you do, but if you're not, we will be live-streaming the event for the convenience of our parents. We certainly need our parents' and guardians' support as we, together, battle the challenges and the dangers that social media and smart devices pose to our children and our students.

3. I will confine my board action to policy making, planning, and appraisal, and I will help to frame policies and plans only after the board has consulted those who will be affected by them.
4. I will carry out my responsibility, not to administer the schools, but, together with my fellow board members, to see that they are well run.
5. I will recognize that authority rests with the board of education and will make no personal promises nor take any private action that may compromise the board.
6. I will refuse to surrender my independent judgment to special interest or partisan political groups or to use the schools for personal gain or for the gain of friends.
7. I will hold confidential all matters pertaining to the schools which, if disclosed, would needlessly injure individuals or the schools. In all other matters, I will provide

R. Questions or Comments from the Public

- Mrs. Vitale, on behalf of the HTAA, recognized Mrs. MacConnell for all of her accomplishments in the district and wished her the best of luck.
- Mr. Loughran spoke about Ms. Conover-Pannone and Ms. Dougherty and all of their accomplishments in the district and wished them both the best of luck in their retirement.
- Mr. Gao, parent, spoke about the school calendar. Observing the Lunar New Year is one symbolic gesture that represents inclusiveness. Holmdel has always observed the Lunar New Year.
- Mr. Rao, parent, referenced issues that were expressed at the last meeting regarding the presenter at Satz. He shared the presenter's (Mr. Damico) extensive history of qualifications and said he doesn't think it's necessary for a special parent group to review his expertise. He shared that, according to the NJDOE, 51% of HIB incidents occurred in middle school in 2019. That percentage increased to 58% in 2020. HIB incidents are more likely to occur in middle school than in high school with Asian and Black students more likely to be targets of HIB. Instead of avoiding conversations of race and hate with middle

school students, they are, in fact, the ideal audience to hear about bullying and hate since a majority of incidents happen at that age. There may have been students who felt uncomfortable and emotional learning about the nasty history of racism and hate crimes in this country, real change comes when it sparks something deep inside of us. Race relations and hate are a hard subject and we are doing a disservice by sugarcoating it or avoiding talking about it, in general. Mr. Rao shared that his 7<sup>th</sup> grade son who attended the presentation was emotionally moved by it and they had a productive and meaningful conversation about it at the dinner table that night and the conversations continued throughout the week. He went on to say that, just last month, he received a notification from the school telling him that his own son had been a victim of a racial attack at Satz, where another student used racial slurs toward him because he had a different skin color. The child who used the racial slur was not born with hate, he learned it somewhere. Mr. Rao shared that it is imperative that we teach children the right way. It is not woke or liberal to want less harassment and bullying in school. Living in a world where our sons and daughters are not bullied for their race, religion, skin color, sexual orientation or disability is not CRT or a political issue, it's a human issue. Mr. Rao commended Dr. Cascone and the Administrators for putting the speaker in front of our children and wanted them to know that the majority of Holmdel parents stand with you and support you in your attempts to reduce hate and help our children become positive change-makers in society.

- Mrs. Liu, resident, referenced the school calendar that was approved tonight and stated the past traditions using days off for students and professional development for staff.
- Mr. Lupe, parent, referenced the past presentations and inquired if parents can obtain audio recordings of them. He also referenced Mr. Wall's comments regarding energy services and thanked him for his recommendation. He stated that everyone should be treating the budget like it's their own checkbook.

After public comments were over, several Board Members made the following comments:

- Dr. Collur provided additional comments/clarification on the school calendar and shared that she believes that all of the holidays, including Eid and Diwali, should be standard in the calendar. Rather than accommodate one holiday or the other, we should accommodate both holidays.
- Mrs. Zhang provided additional comments/clarification on the school calendar and applicable holidays.
- Mrs. Tuccillo provided additional comments on the school calendar.
- Mr. DiMare provided additional comments on the school calendar.
- Mr. Reddy made the final comments on the school calendar and shared that perhaps we can do a Qualtrics survey next year for community input on the calendar.

## 5112 ENTRANCE AGE

The Board of Education will admit to this district children otherwise eligible by law or Board policy who have attained the age requirements set by law and this Board of Education. The Board requires documentary verification of the age and birthdate of any child for whom admission to this district is sought.

### Preschool Disabled

A child is eligible for entrance into a program of special education provided that he/she has attained his/her third birthday and has been found by the Child Study Team to be eligible for a program for the preschool disabled in accordance with rules of the State Board of Education.

### Preschool

A child is eligible for entrance into a program provided that he/she has attained his/her third birthday by October 1 of the year in which entrance is sought.

### Kindergarten

A child is eligible for entrance into Kindergarten provided that he/she has attained the age of five years on or before October 1 of the year in which entrance is sought.

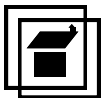
No child will be admitted to Kindergarten who has not met the age requirement set by this policy.

### First Grade

***Regardless of whether the child has attended kindergarten, no board of education is required to accept a transfer student from public or private school who has not turned six by October 1 of that school year. However, the board can admit any pupil if he or she meets such entrance requirements as established by rules or regulations of the board in accordance with N.J.S.A.18A:38-5.***

Any child is eligible for entrance into first grade provided:

- A. The child has attained the age of six years on or before October 1 of the year in which entrance is sought.
- B. He/she has been in the first grade in another public school.***



*C. Proof has been furnished of immunization against communicable diseases.*

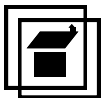

*D. He/she has completed a kindergarten program utilizing a curriculum that is aligned with the New Jersey Student Learning Standards (NJSLS) and will be six years old before December 1 of the school year of entrance. The parent/guardian of the student seeking admission under this section must supply documentation of completion of kindergarten that is aligned with the NJSLS and utilizes NJSLS-aligned assessments.*

*E. A letter of recommendation from either the Kindergarten principal and/or Kindergarten teacher certifying the child's academic and social/emotional readiness for first grade.*

## P2610 EDUCATIONAL PROGRAM EVALUATION (M)

The Board of Education directs the Superintendent to develop and implement a systematic plan for the continuous evaluation of the educational program against the educational goals established by this Board. The Superintendent shall employ such tests and methods that will ensure decision making is data driven and a variety of sources of data are used to analyze and monitor student achievement and progress, as well as evaluate school programs. Wherever possible, the assessment program shall follow evaluation procedures set forth in the course guides.

The Superintendent shall maintain a calendar of assessment activities and shall make periodic evaluation reports to the Board that evaluate the progress of students and the effectiveness of staff members. The Superintendent shall use multiple (more than two) sources of data to monitor student achievement and the progress of students. The Superintendent shall also use multiple (more than two) sources of data to evaluate the effectiveness of programs, initiatives, and strategies.

The Board will annually make available to the public the collective progress of students toward the goals of the district. The Board will annually, prior to the end of the school year and in conjunction with appropriate members of the administrative staff, conduct a review of the educational progress of the district, assess district and student needs, and establish long range and short range objectives for the educational program. The Board's annual report will be submitted to the Commissioner of Education as required.

The Superintendent shall annually recommend improvements in the educational program based on the Board's evaluation of the district's program. The Board reserves the right to employ experts from outside the school district to serve in the evaluation process.
