Dr. Cascone reported the following Enrollment Data as of June 28, 2023:

The Holmdel Public Schools successfully closed out the 2022–23 school year last week. William R. Satz Middle School held their graduation ceremony on Monday, June 19<sup>th</sup> awarding certificates of completion to 272 students. We wish all the rising ninth graders congratulations and all the best as they move on to begin their high school careers whether at Holmdel High School or at other secondary academic institutions.

On June 20<sup>th</sup>, Holmdel High School held its historic 50<sup>th</sup> commencement ceremony for the graduating class of 2023. Congratulations to the 223 graduates of the Class of 2023 on achieving this important milestone. Ninety-six percent (96%) of the graduating class will be continuing their academic careers at institutions of higher education. The complete list of colleges and universities can be found on the school district's homepage but it is an impressive array of institutions of higher learning and, of course, we are very proud of our students, their folks and our school district, all of whom played a role in this achievement.

Later that evening, on June 20<sup>th</sup>, the graduates enjoyed a safe and fun celebration at the Project Graduation event held at Sportika in Manalapan. I had an opportunity to swing by for several hours and the school district is tremendously grateful for the tireless efforts of the Project Graduation organizing committee, all the parent volunteers who came out that night to support the event and the generous donors who helped fund it.

On Tuesday, June 27<sup>th</sup>, the district administrative team met for its annual June planning retreat. The team engaged in a debrief of this past year's goals, accomplishments, and ongoing priorities, teambuilding exercises, as well as a number of vital trainings were conducted. The administrative team will continue to meet throughout the summer for weekly roundtable meetings to maintain a focus and continuity of planning.

Tomorrow, Thursday, June 29<sup>th</sup>, the strategic plan task forces will meet for an all-day action planning session. The task forces are optimistic that draft action plans will be completed by the end of the day. A half-day session is currently scheduled for July 6<sup>th</sup>, in the event that it is needed. A draft action plan will be prepared to share with the Board in July and with the community in August, in advance of the next school year.

Finally, in closing, the summertime in the school district will continue to be bustling with activity as the district will host its Extended School Year Program for students with specialized learning needs, as well as the Summer Step Programs and Theater Arts Performing Camp. The Buildings and Grounds Department, as always, will be hard at work not only in carrying out the annual deep cleaning and maintenance of the school district's facility; but also engaged in a number of renovation and light construction projects.

- 6) By adoption and signing of this resolution, the Educational Institution is hereby joining NJSIG in accordance with the terms of this Indemnity and Trust Agreement and Resolution to Join / Renew membership, effective the date indicated below, for the types of insurance as indicated in the Insurance Binder issued by NJSIG;
- 7) The Educational Institution hereby ratifies and affirms the bylaws and other organizational and operational documents of NJSIG, and as from time to time amended by NJSIG and/or the State of New Jersey, Department of Banking and Insurance, in accordance with the applicable statutes and regulations as if each and every one of said documents were re-executed contemporaneously herewith;
- 8) The Educational Institution agrees to be a participating member of NJSIG for the period herein provided for and to comply with all of the rules and regulations and obligations associated with said membership, including, but not limited to the NJSIG's Plan of Risk management;
