A. Call to Order

The Board of Education, Township of Holmdel, met in a Committee of the Whole Meeting on Wednesday, September 20, 2023 at Holmdel High School, 36 Crawfords Corner Road, Holmdel, New Jersey. The meeting was called to order at 6:02 p.m. by Mr. Reddy, Board President.

B. Open Public Meetings Act

F. Call to Order

The Board of Education, Township of Holmdel, met in a Committee of the Whole Meeting on Wednesday, September 20, 2023 at Holmdel High School, 36 Crawfords Corner Road, Holmdel, New Jersey. The meeting was called to order at 7:10 p.m. by Mr. Reddy, Board Vice President.

J. Old Business

- 1. New Turf Field Field Lights Discussion
 - Mr. Reddy shared that leadership has not received any formal notification from the Township on whether or not they will be able to provide funding.
 - Dr. Cascone provided a brief overview of this topic and then it was decided that the Board would discuss this topic at an upcoming meeting.
 - Mrs. Briamonte provided some background on field lights, sharing that, when the second turf field was being put in, the existing Board, at that time, decided to move forward with the turf field but not pay for lights. Conduit was run during the installation so that it would be easy for a user group or multiple user groups to fund the lights. Mrs. Briamonte shared that we are in the business of education our students and providing activities in and around school. Mrs. Briamonte also referenced budget concerns and that the Board shouldn't even consider this.
 - Mrs. Zhang asked how many of our district teams are utilizing the field after dark and would require lighting and Dr. Cascone responded zero.
 - Mr. Wall made additional comments and shared that the Board was not unanimous with regard to the lighting on the field when the turf field was built.
 - Dr. Collur referenced budgetary concerns and shared that this is an item that can be discussed at a future Board meeting.
 - Mr. Reddy made final comments and moved onto the next topic.

K. New Business

- 1. Policy #5756 Discussion President Reddy moved this item up to be discussed immediately following Questions/Comments from the Public and prior to Old Business.
 - Dr. Cascone provided an overview of this matter and made additional comments regarding Policy #5756.
 - Dr. Collur thanked the public for their input and shared that she needs more time in order to make a decision on Policy #5756 and suggested the Board hold off in order to give the Ad Hoc Policy Committee an opportunity to review and consider all policies. She also shared that, while this is an important topic, the Board's focus has been shifted from curriculum and academics.

Mr. Mann echoed Dr. Collur's comments regarding the Board getting back to focusing on education and referenced one of the public comments regarding a statement that was made at a previous meeting. Mr. Mann then shared that, if a student expresses mental illness (in any capacity), parents should be notified.

Mr. DiMare referenced the injunctions in other districts and stated those districts were trying to amend the Policy which is very different from repealing the Policy, which is what Holmdel is considering. Mr. DiMare shared his thoughts on the Policy and expressed the need to for children to feel safe and teach them that it is ok and important to involve their parents in difficult conversations. Further, Mr. DiMare stated that he does not support this policy and is ready to act on it this evening.

Mr. Wall referenced Policy #5756 and shared the reasons why this Policy should be withdrawn and feels the contract with Strauss Esmay should be cancelled. Mr. Wall shared that this is not about LGBTQ. This is about severing a relationship between children and their parents and the sooner the policy is rescinded, the better.

Mrs. Tuccillo referenced two specific sentences in the Policy and shared her thoughts on the Policy. She shared her thoughts and expressed that she needs more time and that the Policy was included on tonight's agenda as an item for discussion (only) and does not feel there should be a vote on this Policy this evening.

Mrs. Briamonte thanked everyone for coming and speaking tonight. She shared that, based on conversations with Dr. Cascone, we currently have transgender students here in the district and are not experiencing any issues. There are open lines of communication with staff members, guidance counselors and parents which seems to be working really well. Mrs. Briamonte referenced transparency and stated this item was listed as a discussion point only for tonight's Committee of the Whole meeting and the Board shouldn't be voting on it this evening and stated that, if the Board is planning to vote on this item, it should occur at next week's Board meeting.

Dr. Collur had a follow up question regarding whether holding off on voting would put the District at risk. Ms. Gilfillan shared that it appears the district would not be in jeopardy and clarified that the four districts involved in litigation actually changed their policy to require parental notification and that repealing the policy is a different situation.

Dr. Collur asked if the district would still be required to notify parents if the policy is repealed. Ms. Gilfillan stated that, if the policy is repealed, that does not affirmatively direct staff members to notify parents of any specific issue going on with their student relative to the gender identity discussion. So that is still left in the hands of the education professionals. However, Ms. Gilfillan mentioned, there is absolutely law in New Jersey that speaks to having to notify parents of any situation which poses an immediate risk of harm, if the student is speaking of harming themselves or harming others, the absolutely is a requirement that the district notify the parents.

Dr. Collur again restated her position that she needs more time in order to make a decision on this policy.

Mrs. Zhang thanked everyone for providing their perspective and referenced the rush of adding this Policy to the agenda. She stated that she also needs more time in order to make a decision on this policy and that she will not be voting tonight.

Mr. Reddy made follow up comments regarding this policy (and others) and shared that he does not think the Board should be voting on this. For tonight, it should be a topic for discussion only, as it has been. He thanked everyone for sharing their viewpoints and stated that he is not asking for a resolution tonight and suggested waiting until next week.

Mr. Wall made follow up comments.

Ms. Gilfillan explained the Board's process regarding making and/or repealing policies.

The Board conducted a straw poll on placing this policy on the September 27th agenda for repeal.

Mrs. Briamonte, Mrs. Zhang and Dr. Collur did not vote as they needed additional time to form an opinion on the matter.

He went on to say that it would be premature for the Board to discuss any further at this time as it is very early and that the Board and Township have a call scheduled for tomorrow.
